**TOURNAMENT RULES**

1. All participants must hold a current USBC membership card, and be “active” members of the PVTBC.
2. **This is a Snake Bite Singles fun tournament. For every split you reset the pins and take a strike for that frame.**
3. **FORMAT:** A SinglesTournament by Division (with handicap). “A” Division will be bowler with an entering average of 181 and higher; “B” Division will be bowler with an entering average of 156 to 180 & “C” Division will be bowler with an entering average of 155 or less.
4. **ENTRY FEE:** The entry fee for this tournament is \$15.00 per person. \$7.50 to lineage, and \$7.50 to the prize fund. An additional \$2.50 per person will be added to the prize fund from the Sponsor fee. Checks or Money Orders should be made out to PVTBC .
5. **PRIZE FUND:** Payoff ratio is at least one (1) place for every four (4) team entries (with handicap and by Division). Side pot will be by individual series and computed as series plus handicap, (not by division) and payoff ratio is also at least one (1) place for every four (4) entrants. Payouts are 100% of total side pot and tournament prize fund and will be made within 14 days after the tournament.
6. USBC Playing Rules 319d and 319e will not apply for this tournament. All other USBC Playing and Tournament rules apply. Any disputes, complaints, or problems concerning a players eligibility, or noncompliance with playing rules that may arise during tournament play, will be immediately submitted to tournament officials, the decision of the tournament official shall be final unless a written appeal is filed in accordance with USBC Rule 329.
7. No refund of entry fees once the tournament has started. Board of Directors may grant an exception. Entry fees will be returned to entrants unable to bowl because of entry limitations.
8. Entering averages to be used will be in the following order:
  - a. Highest USBC winter book average for 2008-09. However, if an entrant’s current league average for 21 or more games, as of April 30, 2010, is 10 pins or higher than highest book average, the current league average must be used. (USBC rule 319a2)
  - b. If no 2008-09 or 2009-10 Winter Book Average, entrants must use highest current league average of at least 21 games as of Aug. 23, 2010. Entrant will furnish a copy of their latest league standing sheet to verify average.
  - c. If no book or current league average entrant must use 230.
  - d. All submitted averages will be verified and corrected by the club Secretary if necessary.
9. Handicap will be based on 90% of the difference of the bowler’s average times 3 and 690.
10. Reserved Entry deadline is 12 p.m. Aug. 27,2010. Reserved entries must be dropped off at the Nugget Bowling Center, to be received by 12 p.m. Aug. 27<sup>th</sup>. Entry deadline for walk-ins is 12:00 p.m. for the 12:30 squad and 2:30 p.m. for the 3:00 p.m. squad. If reserved entries for the 12:30 squad exceed 56 entries, the latest received entries will be automatically rescheduled for the 3:00 p.m. squad, unless entrant’s rejection of such re-scheduling is noted in the remarks/request section of the entry form. Entrant’s that can not be scheduled for the 12:30 squad will be notified by 10 p.m. Aug. 27<sup>th</sup> Individuals bowling in the first squad may bowl again in the 3:00 p.m. squad, if the entry form is turned in by 2:30 p.m. and space/lanes are available. Individuals that have submitted entries for the 3 p.m. squad only will be given first priority. The number of entries that may be accepted for the second squad is limited to 56. There will be no exceptions to this rule. (USBC Rule 310b)
